CANDIDATE'S GUIDE FOR POSTING POLITICAL SIGNS

1. Per City Code, Chapter 151-5, Paragraph A and City Attorney Opinion, 9 July 2014, political signs are not permitted in City right-of-ways. Signs located in City right-of-ways will be removed by City Code Enforcement Officials.
2. Rule of Thumb: City right-of-ways vary but for the main arteries into and out of the City typically measure 35ft from the centerline of the street. More narrow interior streets within the City measure less but some right-of-ways extend up to or include the front of the structure on some properties. In these instances signs should be placed as close to the front the structure as possible.
3. Political signs may be located on private property without a sign permit or fee provided they do not interfere with pedestrian/traffic safety or create visual clutter. In these instances, Code Enforcement will request property owners re-located or remove the signs.
4. Per City Code, Chapter 151-3, the sign cannot be erected more than 60 days prior to the election to which it relates and the sign will not remain more than seven days after the election.
